



Community Reentry Program Overview Focused on improving continuity of care for patients

The INSUPPORT® Community Reentry Program (CRP) is available to eligible patients who meet the below criteria.



PATIENT ELIGIBILITY*:

- Previously administered SUBLOCADE® (buprenorphine extended-release) by their treatment provider
- Recently released from the criminal justice system
- · On-label use
- Insurance coverage is pending approval
- Resident of the United States or US territories *Additional terms and conditions may apply.



Eligible patients

may receive up to 2 months of SUBLOCADE at no cost

ENROLLMENT AND NEXT STEPS:

Enrollment

To enroll in the Community Reentry Program, complete the Patient Enrollment Form for SUBLOCADE. Email the completed enrollment form to enroll@insupport.com or fax all pages to 844-814-0669.

Fax or ePrescribe Prescription and Submit ID Requirements

After the Patient Enrollment Form for SUBLOCADE is submitted, the healthcare provider should fax the prescription to AllCare Plus Pharmacy at 844-470-2806 or ePrescribe through the eRx platform to AllCare Plus Pharmacy, NPI 190216796.

If applicable, submit a copy of the patient's state approved identification requirements, which may vary by state.

Dispensing Pharmacy Follow-up

If the patient is approved, the provider will receive a follow-up call from the CRP dispensing pharmacy to verify the patient's next injection and shipping date requirements.

WARNING: RISK OF SERIOUS HARM OR DEATH WITH INTRAVENOUS ADMINISTRATION; SUBLOCADE RISK EVALUATION AND MITIGATION STRATEGY

- Serious harm or death could result if administered intravenously. SUBLOCADE forms a solid mass upon contact with body fluids and may cause occlusion, local tissue damage, and thrombo-embolic events, including life threatening pulmonary emboli, if administered intravenously.
- Because of the risk of serious harm or death that could result from intravenous self-administration, SUBLOCADE is only available
 through a restricted program called the SUBLOCADE REMS Program. Healthcare settings and pharmacies that order and dispense
 SUBLOCADE must be certified in this program and comply with the REMS requirements.






INSUPPORT® CAN HELP PATIENTS AND PROVIDERS LOCATE A SUBLOCADE® (buprenorphine extended-release) TREATMENT PROVIDER, INSUPPORT CAN:

- ✓ Locate a treatment provider based on the patient zip code
- ✓ Fax the requesting provider a list of SUBLOCADE providers
- ✓ Confirm the SUBLOCADE provider is accepting new patients and that they accept the patient's health insurance
- ✓ Confirm the chosen provider is able to see the patient by the patient's next injection due date and schedule the patient's first appointment with the provider
